Rollout of HRT prescription prepayment certificate

From 1st April 2023, women who usually pay for their HRT prescriptions will be able to purchase an annual HRT PPC for the cost of two single prescription charges (currently £18.70). The HRT PPC, valid for 12 months, can be used against any listed HRT prescription item(s) licensed for the treatment of menopause. Find out more on PSNC here.
