HEE to fund 3,000 independent prescribing places in 2023/24

Eligible pharmacists will be able to apply for one of almost 3,000 places on independent prescribing courses at a variety of universities across England. Courses will be available between April 2023 and March 2024, with several universities offering multiple dates for cohort intakes. Start dates will depend on the university provider. Contractors are reminded that by 31st March 2023, they must have completed the 2022/23 national clinical audit on valproate over a six-week consecutive period, and have submitted the data via the Valproate audit 2022/23 tab on the Manage Your Service (MYS) portal.
