Contraception Service launch date announced

NHSE has announced that the Pharmacy Contraception Service will launch from 24th April 2023. This start date, however, has not been agreed with PSNC previously. Read more about this issue on PSNC here. Be aware that to provide this service you must meet the conditions set in the Service Specification. We understand that Cegedim and PharmOutcomes are the only platforms that can be used to record service provision currently. There will be no charge for current PharmOutcomes users to provide the service on their platform until March 2024.

Melatonin 5mg/5ml liquid for Paediatric Patients

It has been brought to our attention that the preferred product for melatonin 5mg/5ml suspension is the unlicensed special and not the licensed special and most prescriptions will reflect this. The prescription itself serves as the 'statement of need' for an unlicensed special should you need to retain copy for records. More information to follow.
