Reminder: Covid pharmacy emergency regulations ended a year ago!

Please remember that the emergency regulations to support pharmacies during pandemic ended over a year ago on 31st March 2022. All pharmacy contractors are reminded to open their full contracted hours, otherwise this is a breach of the Terms of Service.

Please can you check to make sure your pharmacy is open at full contracted hours and update your DoS profile & NHS UK.

- The emergency regulations for the pandemic has been withdrawn since 31st March 2022
- All pharmacies to open on full contracted hours
- It is a breach of Terms of Service if not open on full contracted hours
- Please update your hours on DoS profile & NHS UK

NMS - Changes of Inhalers to greener choices

Just a reminder that you may see more inhaler changes to more environmentally friendly brands in the coming months. It's a great opportunity to deliver the NMS and support your surgeries with implementing the changes. Not all surgeries are able to speak to each patient about the switch and differences in inhalers so it can leave patients with unanswered questions. Be sure to show these patients how to use their new inhalers and, if possible, sign them up to NMS at the same time.

Change to how some GP-CPCS referrals are received

If you use a provider other than Pharmoutcomes for your 111 referrals, your GPCS referrals will now come to your NHS shared email account and not to Pharmoutcomes. You will need to input the referral into your provider system from the NHS mail referral. A reminder to look out for incoming referrals on NHS shared email account if this applies to your pharmacy.
