#### Data Security and Protection Toolkit: CPE Guidance Published for 2023

CPE has published new guidance to help members complete the 2022/23 Data Security and Protection Toolkit. The Toolkit is used to make a pharmacy's information governance (IG) declaration. The deadline is **Friday 30th June 2023**. Find details on CPE here.

## **Price Concessions: Roll-over to June**

As part of a package of measures developed to improve the Price Concession system, DHSC has implemented a process to roll over certain concessionary prices to the following month. From May 2023, the roll-over process applies to any products where agreement is reached on the final prices granted by DHSC for any requests submitted late in the month (on or after the 23rd of the month) by CPE. #### NMS: Voluntary quarterly data returns

NHS England is asking pharmacy owners to continue to voluntarily submit New Medicine Service (NMS) quarterly summary data to the NHS Business Services Authority (NHSBSA) for Quarter 4 (Q4) 2022/23 (January to March 2023). The mandatory requirement to submit this data has been suspended since 2020, due to the COVID-19 pandemic. Find out more on CPE here.

Clinical Examination Skills – offering a step towards Independent Prescribing and an opportunity to gain new specialist skills to increase your NHS role or to expand and refresh your diagnostic and consultation skills if you're already an IP.

**Independent Prescribing** – training to support patients from diagnosis to prescribing, providing advice and follow-up, and preparing to provide clinical care.

## **Moviprep supply issues**

As you may be aware, there are some ongoing supply issues with Moviprep, used for bowel cleansing procedures. UHCW has changed to picolax+ senna as an alternative and they are also trialling **Plenvu** in some patients. UHCW have now started issuing FP10 Rxs for Plenvu. Please be aware that patients may present for this product and it is approved to be used for bowel prep, if available.
