#### **Annual Flu Vaccination Letter Published**

The annual flu vaccination letter for the 2023/24 season has been published. You can find a copy of the letter <a href="here">here</a> and CPE guidance <a href="here">here</a>.

The letter confirms the eligible cohorts for the 2023/24 season and the vaccines which will be reimbursable under the Flu Vaccination Service. The Government has confirmed that 50-to-64-year-olds not at clinical risk are not included as a cohort for this coming season.

#### **CPCS Claim Period Change from June**

NHS England (NHSE) has announced from 1st June 2023, in a change from the previous Community Pharmacist Consultation Service (CPCS) service specification, claims for payment should be submitted within one month of, and no later than three months from the claim period for the chargeable activity provided. The change normalises the grace period for service claims from its previous position of six months to three months, which is the case for most of the other Advanced services.

CPE encourages contractors to ensure they have reviewed and submitted any outstanding CPCS claims on the Manage Your Service portal to avoid any potential service fee losses as a result of this reduced grace period for claims.
