Covid-19 Antiviral Treatment Update CW

If you are one of 16 Paxlovid holding Pharmacies in Coventry and Warwickshire, please remember to stock 4 packs of Paxlovid (an update from the previously required 2 packs), which can be ordered from Alliance free of charge. If you run out of stock, please signpost patients to the other <u>stockholding pharmacies</u>. More information about Paxlovid can be found on our website here.

Nitrofurantoin: reminder of the risks of pulmonary and hepatic adverse drug reactions

Please be aware that healthcare professionals prescribing Nitrofurantoin should be alert to the risks of pulmonary and hepatic adverse drug reactions and advise patients to be vigilant for the signs and symptoms in need of further investigation. Now that this drug is being more widely used within the Extended Care UTI service, you might come across these rare side effects. NHS guidelines can be found here.

Returned inhalers

Please remember that pharmacies should always accept returned inhalers for incineration to support the <u>Greener NHS objectives</u> as it is a more environmentally friendly way of discarding them than through the household waste.

Reminder: Hypertension Case-Finding Service - IT requirements from September

NHS England has announced that pharmacy owners will need to use an NHS approved clinical IT system to make their clinical records and payment claims for the Hypertension case-finding service from **1st September 2023**. Find out details on CPE here and in the following NHS briefing.

Reminder: CPCS - Claim period change from 1st August

The DHSC has announced that from 1st August 2023, the Community Pharmacist Consultation Service (CPCS) claims for payment should be submitted within one month of - and no later than three months from - the claim period for the chargeable activity provided. This is an amendment to the NHS England advice given previously. CPE recommends reviewing and submitting any outstanding CPCS claims on the Manage Your Service (MYS) portal, to avoid any potential service fee losses as a result of this reduced grace period for claims.
