Reminder: AGM 19th October

Community Pharmacy Arden AGM workshop will be on 19th October 2023 at the Holiday Inn Coventry, CV2 2HP (9.30-3.30 – with the AGM over lunch 1-2).

Reminder: PQS Aspiration Payment Window Closes on 29th September 2023

Community pharmacy contractors can now make a claim for an aspiration payment for the PQS 2023/24 on the NHS Business Services Authority (NHSBSA) Manage Your Service (MYS) portal. This payment is optional and not claiming will not impact a contractor's ability to claim payment for the PQS 2023/24 during the declaration period. Contractors who wish to claim an aspiration payment must do so **between 9:00 on 4 September 2023 and 23:59 on 29 September 2023**. The aspiration payment will be paid on 1 November 2023.
