CPPE Accuracy checking pharmacy technician programme – more free places available

NHS England has provided an additional funding for the CPPE to offer the Accuracy checking pharmacy technician (ACPT) programme to an additional 40 pharmacy technicians. Details on CPE here.

Plans for face-to-face ENT clinical assessment skills workshops for community pharmacists in the West Midlands

There are plans for two medic-led half-day workshops on **Sunday 14th January 2024** (morning and afternoon sessions) for community pharmacists which will provide an introduction and opportunity to practice ear, nose, and throat examination skills.
