## **Pharmacy First Referrals**

We have heard some great stories about the success of this service and how much patients have benefitted from the quick access it has provided. We would love to hear some more so please send in any you would like to share to ahwlpc@gmail.com

There have been some IT issues to contend with initially, so we appreciate this has made things difficult to start. There are some reports of referrals not being picked up by pharmacies and also some where the referral has been rejected and the reason doesn't seem to be within exclusion criteria. Where these are reported to us, we will contact pharmacies directly to understand the issue so we can give feedback to the referrer.

Please remember that the service should be provided during all opening hours and any temporary pause will require you to notify the DoS and local surgeries. If you do not have an otoscope or have not yet had training on its use, then please inform your local surgeries who will be making referrals so they don't send these to you. If you do receive a referral for otitis media but cannot offer the consultation then it is important to find out who can and direct the patient onwards to this pharmacy, making sure to call the pharmacy in advance.

## **Covid-19 Vaccination Contracts Extended**

NHS England has written to pharmacies currently providing the COVID-19 vaccination service to ask whether they would be willing to extend the duration of their current contract to provide the service until 31st August 2024.

Pharmacies that are contracted to provide the COVID-19 vaccination service have been asked to inform their local commissioner by **22nd February 2024**, if they can continue offering the service from 31st March 2024 to 31st August 2024.

The Enhanced Service specification has been updated and published on the <u>NHS England website</u>. Minimal changes have been made to it, except the end date and payment arrangements from 1st April 2024. Find out more on CPE <u>here</u>.



#### **New Resources for Valproate Safety Measures**

MHRA has released new safety and educational materials to support the implementation of regulatory measures for valproate-containing products.

These measures aim to reduce known risks, such as harm to babies during pregnancy and impaired fertility in males. The materials include updated guides, acknowledgment forms, patient cards, posters, and warning stickers.

## Drug Alert from Change Grow Live C&W: vapes containing synthetic cannabinoids (SCRA- Spice)

CGL in Coventry and Warwickshire has issued a drug alert warning about vape pens spiked with a synthetic cannabinoid often known as Spice. Find attached a <u>poster</u> warning about dangers and providing safety advice.
