NHS Community Pharmacy Extended Care Service Tier 1, 2 and 3

The West Midlands Primary Care Team have now notified you of the discontinuation in part to the NHS Community Pharmacy Extended Care Service Tier 1, 2 and 3. The service was reviewed by the West Midlands Pharmacy Governance Group and it was concluded not to offer the service after 31 March 2024. This decision was made due to launch of the Pharmacy First Service which commenced on 31 January 2024, it was recognised that four of the clinical pathways from the extended care Tier 1,2 and 3 services, were to be incorporated and have been aligned to the new advanced pharmacy first services. Zero VAT rate for medicines supplied using a PGD

Last year the application of VAT to pharmacy services and medicines changed. See https://cpe.org.uk/funding-and-reimbursement/pharmacy-funding/funding-distribution/vat/.

The change that does not appear to have been fully implemented relates to medicines and PGDs – at the bottom of that web page. Specifically:

HMRC subsequently announced that from 9th October 2023 to 31st March 2027, the VAT rate for supplies of medicines made to patients using a Patient Group Direction (PGD) would be set at the zero rate. This change **only applies** to PGD supplies where the patient is given the medicine to use; it **does not apply** where the medicine is administered to the patient, for example vaccination services, including the <u>flu vaccination</u> service. We have been made aware that some PharmOutcomes invoices for PGD services provided to contractors are continuing to charge 5% or 20% VAT on medicines supplied as part of a PGD service. This is not correct. The current rate is zero. PharmOutcomes is not able to initiate the necessary changes – the changes must be requested by the commissioner/person holding the PharmOutcomes licence. The LPC have contacted all the relevant commissioners.

Community Pharmacy NHS Lateral flow device (LFD) tests supply advanced service for patients potentially eligible for COVID-19 treatments – Service Expansion

The NHS offers COVID-19 treatment to people with COVID-19 who are at risk of becoming seriously ill. From 1 April 2024, as a result of updated NICE guidance, the number of people estimated to be potentially eligible for COVID-19 treatments through routine NHS access pathways will increase to around 5.3million.
