Important Regulatory Changes Affecting Distance Selling Premises (DSP) Pharmacies and Core Opening Hours

From 23rd June 2025, the DSP market entry exemption will close and a more flexible application process will be introduced for changing a pharmacy's core opening hours. A further change to prevent DSP pharmacies from delivering Directed services face-to-face with patients onsite will also come into effect later this year. Sign-up Process Launched for Provision of COVID-19 Vaccinations from October 2025 (Deadline for Submissions is 16th June 2025)

NHSE has opened the procurement process for pharmacies that wish to provide the COVID-19 Vaccination Service from their premises from 1st October 2025. This only applies to:

- Pharmacies not already contracted to provide the service and wishing to apply to provide it from 1st
 October 2025; and
- Pharmacies already contracted to provide the service but whose contract only runs up until the end of August 2025.

Most pharmacies already providing the service are contracted until 31st March 2026; those pharmacies **do not need** to re-apply in order to continue to provide the service from October 2025, as their contract already covers provision until 31st March 2026. Community Pharmacy England has published new guidance to help community pharmacy owners complete the Data Security and Protection Toolkit 2025. The Toolkit is used to make a pharmacy's information governance (IG) declaration and must be completed **by 30th June 2025.**

Key differences in this year's Toolkit include:

- A new question asking if you are using multi-factor authentication with your clinical IT systems
- Improvements to the Toolkit's layout.
- Improvements to the question wording and pharmacy-specific tips.
- The Toolkit displays the answers submitted by the pharmacy in the previous submission for various questions, allowing pharmacy teams to simply confirm that the information remains accurate and adjust this if necessary.

NHS England launches vaccine IT system framework

NHS England has announced the launch of a new community pharmacy Point of Care (PoC) IT Supplier Contractual Framework, which will allow pharmacy owners to choose which PoC system they use to make their clinical records for the <u>Flu</u> and COVID-19 vaccination services during the Autumn/Winter 2025/26 campaign.

IT suppliers listed on the new framework have been assured by NHS England as having met specific minimum standards.
