Provisional dates of CPCF changes announced

Provisional dates have now been announced for the agreed changes to the Community Pharmacy Contractual Framework for 2025/26 to be introduced. These are summarised in the table below but please refer to the CPE news story here for full details including what you need to do to prepare for these changes.

Service	What's Changing	Provisional Commencement Date
Pharmacy First	Revised Clinical Pathways & PGDs. Draft versions can be downloaded here .	1st October 2025
Pharmacy Contraception Service (PCS)	Expansion of service to include oral emergency contraception. Addition of Pharmacy Technicians allowed to provide the service. Addition of drospirenone to the progesterone PGD to enable the supply of this medicine. Download the CPE briefing on what's changing here .	29th October 2025
New Medicines Service (NMS)	Expansion of service to include depression as an eligible therapeutic area. The revised service specification and drug list can be downloaded here .	29th October 2025

NHSE will confirm the various commencement dates nearer the time which are subject to the necessary changes to the clinical IT systems.

National Health Campaigns for 2025/26

As part of the CPCF arrangements, community pharmacies are required to deliver **two national health** campaigns and **two local health campaigns** in 2025/26.

The first national campaign will focus on promoting Pharmacy First to the public. This will run later in 2025, alongside an NHS England advertising campaign. All pharmacies will be expected to participate using relevant promotional materials. The health campaign will take place alongside an NHS England advertising campaign promoting Pharmacy First to the public.

Reminder: PQS Clinical audit window now open

The Pharmacy Quality Scheme (PQS) Antimicrobial stewardship – Pharmacy First consultations – clinical audit can be started **from 1st September 2025**.

Completion of the audit, as well as sharing anonymised data with NHS England and incorporating any learnings from the audit into future practice **by the end of 31st March 2026**, is a quality criterion in the Patient safety domain of the 2025/26 Scheme. More information on CPE here.

Mounjaro® reimbursement prices redetermined for September 2025

Following a decision taken by Eli Lilly to increase its UK list prices for Mounjaro® (Tirzepatide) KwikPen® from 1 September 2025, the Department of Health and Social Care (DHSC) has re-determined the NHS reimbursement prices for all strengths of Mounjaro® dispensed from September to reflect the new, higher list prices.
