Warwickshire Local Drug Information System (LDIS)

LDIS is a rapid-response system for picking up unusual, concerning or emerging cases that may point to wider risks for our community.

Please email ldis@warwickshire.gov.uk if you see:

Overdoses or deaths with unusual features or toxicology Clusters or spikes in drug-related incidents Cases involving under-18s Anything that feels "new, odd or worrying"

Useful information to report includes:

time, date, location of the incident outcome (e.g. ambulance attended, taken to hospital, etc) anything notable about the substance used (drug type, different source, different potency, different appearance, etc)

Your frontline insights are vital, even short notes or suspicions can make a real difference to preventing further harm to drug users, to keep them and the public as safe as possible in Warwickshire. Thank you for your participation in making our community safer.

REGIONAL/ NATIONAL NEWS

Expansion of the PCS and NMS services now live

From 29th October, community pharmacies across England can offer expanded NHS services to make emergency contraception and support for people prescribed antidepressants more accessible in local communities.

Under the expanded Pharmacy Contraception Service (PCS), pharmacies are able to provide women across the country access to oral emergency contraception, whilst depression has been added as a new therapeutic area to the New Medicine Service (NMS).

Reminder: Pharmacy First National Health Campaign

The first 2025/26 mandated national health campaign started on 20th October and is running until 9th November. All pharmacies are required to participate in the campaign, using relevant materials to promote the Pharmacy First service to the public.

Pharmacy owners can meet the requirements of the campaigns in several ways, by promoting the Pharmacy First service to the public during the campaign period, for example:

- By displaying posters, leaflets or other promotional materials relating to the Pharmacy First service at the pharmacy;
- Via information on your pharmacy's website;
- Via information posted on your pharmacy's social media channels; and
- By including information on the service in emails or SMS you send to patients.

NHSmail Rebranded NHS.net Connect

NHSmail is being rebranded to NHS.net Connect, which includes a new homepage with easier access to email, Teams, OneDrive and support. There are no changes to email addresses or logins, and no action is required from pharmacy teams.





Pharmacy owners must ensure the shared NHS.net mailbox is accessible and linked to at least two staff members with personal NHS.net accounts. To keep accounts active, staff should log in at least once every 30 days.

Opportunities to take part in NHS research: surveys and pilots

Please find below information regarding various surveys and pilot opportunities for your attention.

NHS App piloting of medicine readiness notifications: Pharmacy teams (and especially all CP ITG pharmacy reps) are encouraged to join an Autumn 2025 pilot testing of NHS App notifications regarding medicine readiness. Aim: improve prescription notifications for patients. To join, complete the NHS App Expression of Interest Form (requires an NHS App-integrated pharmacy EPS system being used).	Pilot for pharmacy reps to <u>sign-up</u> to
New Scan-to-Shelf & apps digital medicines survey: Pharmacy reps are encouraged to please complete this new Scan-to-shelf, digital medicines & NHS App survey for pharmacy reps (about 9 minutes needed) published at time of CP ITG. The feedback on the new NHSE survey will help the NHS Digital Medicines team, CP ITG and the sector understand the challenges faced, identify areas for improvement, and shape extra NHS App development to support pharmacy teams and their patients better. Pharmacy feedback shaped the questions. Summary results will also be shared back to CP ITG.	New <u>survey</u> for pharmacy owners and teams to complete now
EPS Tracker (upcoming 'Tracker 2') changes and pilot opportunity: Pharmacy teams are encouraged to trial the updated 'EPS Tracker 2' and share feedback. You can apply through the <u>Tracker pilot form</u> .	Pilot for pharmacy reps to <u>sign-up</u> up for testing and early access

Additionally, NHS England is working with a research agency to explore how the NHS App and its guidance can better support pharmacy teams – with patient NHS App queries (e.g. sign-up, records info etc). Pharmacy reps who can express interest with a remote interview (planned during second half of October or within earlier half of Nov) are encouraged to complete this NHS research mini contact form [1-min completion].

Supply issues: Extended Cefalexin SSP

DHSC has announced a further extension of the Serious Shortage Protocols (SSPs) for Cefalexin 125mg/5ml oral suspension sugar free (SSP077) and Cefalexin 250mg/5ml oral suspension sugar free (SSP078). Due to continuing supply issues, both SSPs will now be in place until 28th November 2025. Details here.

- Amiodarone 100mg and 200mg tablets
- Mometasone (Asmanex Twisthaler®) 200micrograms/dose dry powder and 400micrograms/dose dry powder inhalers
