Pharmacy Opening Hours: Christmas and New Year Bank Holidays

Please find below details of pharmaceutical provision across Coventry and Warwickshire for the upcoming **Christmas and New Year Bank Holidays:**

- 25th December 2025
- 26th December 2025
- 1st January 2026

Additional pharmacies may also be open on this date, and this can be confirmed via the <u>NHS.UK</u> website, where pharmacies can be located by completing a postcode search <u>Find a pharmacy – NHS (www.nhs.uk)</u>

Pharmacy premises must exhibit a notice, based on information provided by the Office of the West Midlands, of times when the premises are not open. Where practicable the notice should be legible from outside the pharmacy premises, specifying the addresses of other NHS pharmacies and the days on which and times at which drugs and appliances may be obtained from those addresses.

Pharmacy contractors are expected to have updated their own NHS UK and DoS profiles. If DoS Profile has not been updated in time, pharmacies will need to request emergency profiling changes by the DoS team by phoning 0300 0200 363.

Reminder: Patient Choice for Pharmacy EPS Nominations

Pharmacy owners and teams are reminded that patient choice is fundamental under NHS Terms of Service: **nominations must only be made with explicit consent**, and patients can change their nominated pharmacy freely. This includes where a pharmacy has closed, temporarily closed, relocated, changed ownership or newly opened. Please ensure that changes are only made at the patient's request, as we have had a lot of concerns raised across the Midlands including in our LPC areas. It is causing a lot of extra work and confusion for patients when their medication is not at the pharmacy they expect. It is always leading to a number of formal complaints.

Paxlovid Ordering Over Christmas

There is no stock holding agreement in place for Paxlovid, and due to its high cost, it is not expected that pharmacies order in advance of the holiday period.

If a prescription is received, stock is available to order from **Alliance Healthcare tel. 0344 8547749** but usual holiday delivery timescales will apply. It is important to make patients aware of this before ordering. REGIONAL/ NATIONAL NEWS

Flu Vaccine Stock Availability

Reports in the media have suggested that pharmacies across England are running low on flu vaccines, with potential shortages of appointments in some areas. Reports indicate a very contagious flu could make this winter the worst yet, with more people seeking vaccination.

While there is no national shortage, there have been isolated reports of pharmacies struggling to obtain stock and this was flagged to DHSC and NHS England. NHS England has since assured pharmacy owners that flu vaccine stocks remain available to order. Find out more on CPE here.

C-19 & Adult Flu Vaccination: Joint 2026/27 Service Specification Published

- New joint service specification for COVID-19 and adult flu vaccinations published.
- COVID-19 vaccinations become an Advanced service.
- Fees for both vaccinations uplifted, but additional fee for housebound patients removed.
- Pharmacy owners must use the National Booking Service (NBS) for COVID-19 vaccinations, but this is still not a requirement for flu.
- Registration for spring COVID-19 campaign opens from 5th January, and pharmacy owners must register by 2nd February 2026 to guarantee supplies in time for the start of the spring season.
