Bank holiday direction Rota

NHS England has a duty to ensure that there is adequate pharmacy provision over all bank and public holidays (including Easter Sunday). If NHS England believe that there is not adequate provision we may issue directions to one or more pharmacies, requiring them to open.

Please note, that if you are issued with a Direction to open on 31st August 2026, the payment will be paid at £275 (per hour). Head Offices/Corporates – a spreadsheet sent under separate cover with a list of opening intentions will be accepted.

Please complete by 5th May 2026.

Pharmacy Contraception Service – Key Reminder

Please ensure patients are supplied with *at least 6 months* of oral contraception where clinically appropriate.

- ◆ This aligns with national service requirements
- ◆ Supports continuity of care and adherence
- ◆ Reduces unnecessary repeat consultations and system pressure
- ◆ Improves patient convenience and outcomes

Only supply less than 6 months if there is a clear clinical reason (e.g. new start, side effects monitoring, clinical uncertainty)

- Routine repeat supply = 6 month minimum.

Final call for pressures experiences

There are just a few days left to report your experiences of the intense challenges facing community pharmacy. C-19 LFD service: commissioning continues through 2026/27

The Lateral flow device tests supply service for patients potentially eligible for COVID-19 treatments (LFD service) will continue to be commissioned as an Advanced service through 2026/27.

NHS England has agreed the fee for provision of the service will increase to £4.19 + VAT from 1st April 2026, following a request from Community Pharmacy England for an increase in the fee to reflect inflationary pressures.

NHS prescription charges remain at £9.90

Pharmacy teams are reminded that the NHS prescription charge remains at **£9.90 per prescription item for 2026/27**.

A [Government press release](#) (released on 21/11/2025) previously confirmed that the NHS prescription charge would be frozen for 2026/27, as well as the costs for prescription prepayment certificates (PPCs).

The list of 2026/27 prescription-related charges are outlined below.

| NHS charges for | 2026/27 |
|----------------------------|----------------|
| Single prescription charge | £9.90 |
| PPC 3-month | £32.05 |
| PPC 12-month | £114.50 |
| HRT PPC | £19.80 |

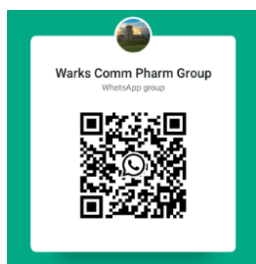
